

## **DO YOU KNOW: Riparian Corridor Overlay Zone - Salem, CT**

### **What is the Riparian Corridor Overlay Zone?**

Administered and regulated by the Salem Planning and Zoning Commission, the zone is a narrow strip of land along perennial streams that provides critical protection to the Eightmile Watershed. The goal of the zone is to preserve water quality, maintain fish and wildlife habitat, filter nutrients and reduce sediment deposits.

### **Does it apply to me?**

The zone only applies to areas within 100 or 50 feet of certain watercourses in the Eightmile Watershed. Go to [www.eightmileriver.org/zone](http://www.eightmileriver.org/zone) to find out if your property is in the Riparian Corridor Overlay Zone.

### **How does it work?**

Just like any other 'zone' in town, the Riparian Overlay Zone serves as a tool to limit and guide activities within 100 or 50 feet of perennial watercourses. Within 100 ft of larger and 50 ft of smaller streams, (see maps at [www.eightmileriver.org/zone](http://www.eightmileriver.org/zone)) certain activities are *as-of-right*, other land disturbing activities require a permit and higher impact activities require a special permit. The zone respects pre-existing activities and allows uses within the overlay area consistent with the protection of riparian corridor function.

### **What does it regulate?**

All land-disturbing activities are regulated - but many as-of-right activities do not require a permit. For example, continuance of any existing activities in existing locations such as mowing and maintenance of lawns, fields, farming, footpaths, horseback riding and utility improvement are all allowed as-of-right and do not require a permit.

## **I want to do more than the as-of-right activities**

Intermediate activities, within certain limits, are allowed in the zone with a permit. This includes small agricultural activities, conservation activities, forestry practices, minor land disturbing activities such as small gardens and simple stream crossings for example.

## **What about bigger things like new buildings & land clearing?**

Larger activities or those with a significant potential to degrade the existing vegetative buffer require a Special Exception Permit. Among other activities, these include building new structures, alteration of a current existing activity, and stream crossings with excavation or structures.

## **How does the Zoning Commission decide what activities are allowed?**

Standards are provided to guide the commission in its decision making. Issues that are considered include will the activity have an impact on the purposes of the zone? Will strict application of the zone deny reasonable use and are there better alternatives for the buffer than proposed?

If your property is in the zone and you have or are contemplating activities, please read the entire Riparian Overlay zoning regulation document available at the Salem Town Hall or on-line at [www.eightmileriver.org/zone](http://www.eightmileriver.org/zone). Be aware that activity in or near wetlands or watercourses requires a separate permit from Town Hall. Your understanding and cooperation will help keep the Eightmile Watershed pristine and unique for generations to come.
